Rural Healthcare Grant Monitoring (RHG) by USDOL

The USDOL monitoring of the Rural Healthcare Grant is underway through the week with an exit conference on November 23, 2022. The monitor is conducting a very thorough review. The number of participants served and the number in training align with the goal set forth in the grant. Expenditures of the grant are slightly behind. Everything seems to be going well and have no concerns about the monitoring. A report is expected 45 days following the monitoring. We will have 30 days to respond to the report.

Modification of Performance Support Grant Project

There are three projects connected with the WIOA Performance Support Grant. The grant goes until March 30, 2023. Grant funds were received late.

- One was Youth Career Connect to support dual credit programs with Ivy Tech in Kokomo. Ivy Tech
 found other funding to support last year due to the contract delay, but we are assisting with funding
 this school year.
- The second was to support renewable energy and solar panel installation. One class finished training but there was no company to hire them. A modification was submitted to DWD to do on-the-job training for individuals who are disengaged from the labor force. We are working with Trinity Mission connecting individuals who have completed drug and alcohol rehabilitation and connecting them with jobs. The modification was approved.
- A third was to work with WorkLife Partnership with a focus on employee retention by providing additional services for their employees. It has been difficult to get businesses engaged. Deb Waymire has scheduled a conversation with WorkLife Partnership.
